

FACTS	WHAT DOES WESTLAKE FINANCIAL SERVICES (“WFS”) DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and income</li> <li>▪ account balances and payment &amp; transaction history</li> <li>▪ credit scores and phone numbers</li> </ul>
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons WFS chooses to share; and whether you can limit this sharing.

## What we do

How does WFS protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does WFS collect my personal information?

We collect your personal information, for example, when you

- give us your contact information
- apply for financing or apply for a loan
- pay your bills or provide account information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include financial companies such as Wilshire Consumer Credit, Loan Center, 1(800) Car-Title, INeedCashNow.net, and 123FundMe, Toyota of North Hollywood, Car Harmony, Midway Rent a Car, Knight Management Insurance Services, Knight Insurance Company, and KnightBrook Insurance Company; nonfinancial companies such as Nowcom Corporation and GlobalTrack GPS LLC.

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Nonaffiliates we share with can include auto related companies.

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Our joint marketing partners include dealerships with which we have a business relationship.

## Other important information

**California Residents Only:** California residents have additional rights to limit sharing. Please see the enclosed "Important Privacy Choices for Consumers" notice provided to you describing your right to control the sharing.

**Vermont Residents Only:** We will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
